

AGREEMENT

about cooperation in the field of higher, post-graduate education and scientific exchange

between

West-Kazakhstan Agrarian-Technical University named after Zhangir khan (Kazakhstan)

and

"Ion Ionescu de la Brad"
University of Agricultural Sciences and Veterinary Medicine from Iași
(Romania)

No.: May 1 st , 2013.

The republican state enterprise on the right of economic management «West Kazakhstan Agrarian-Technical University named after Zhangir khan», in the name of the Rector BOZYMOV Kazybai Karaevich operating on the basis of the Charter, on the one hand, and the "Ion Ionescu de la Brad" University of Agricultural Sciences and Veterinary Medicine from Iaşi, in the name of Rector Prof. dr. VÎNTU Vasile, operating on the basis of Charta, on the other hand, called further "Parties", proceeding from mutual aspiration of the people of Romania and the Republic of Kazakhstan to develop friendship, trust and cooperation, and having overall aims in the field of higher, post-graduate education and science, have agreed about following main principles of cooperation:

1 Subject of the contract

- 1.1 Subject of the Contract is cooperation establishment in education sphere and sciences between the Parties in the areas representing mutual interest.
- 1.2. The parties according to the legislation of the states and within the limits of the powers agree to develop the international cooperation on the basis of equality and mutual benefit in the directions defined by article 3 of the given Contract.

2 Purpose of the contract

2.1 Purpose of the Contract is the establishment, expansion, development and strengthening of international contacts of the Parties on the basis of use of various forms of co-operation as a matter of experience and possibilities of the Parties.

3 Basic directions of cooperation

- 3.1 With a view of realization of the Contract, the Parties define following fields of knowledge, education and research:
 - «Production technology of livestock products», «Technology of processing manufactures», «Health and safety and environment protection», « Production and technology of processing of the Animal Origin Products», «Fish industrial», «Agronomics», «Wood resources and forestry», «Soil science and agrochemistry», «Plant protection», «Agrarian techniques and technology», «Veterinary medicine», «Veterinary sanitary», «Ecology».
- 3.2 With a view of realization of the Contract, the Parties define following directions of cooperation:
 - Academic exchange of teachers, doctoral candidates, post-graduate students, undergraduates and students;
 - Conclusion of direct agreements with scientists of the Parties;
 - Carrying out mutual research and developmental works on the basis of higher education institutions;
 - Scientific exchange according to doctoral studies and magistracy programs;
 - Mutual passing of foreign training of doctoral candidates and undergraduates of the Parties;
 - Mutual studying and exchange of skills on preparation of PhD doctors and doctors on a profile;
 - Organizing and passage of practice and training of doctoral candidates, undergraduates and students;
 - Exchange of experience on introduction and development of the advanced methods of training;
 - Carrying out of scientific researches in actual directions;
 - Working out and realization of joint educational and scientific projects (programs);
 - Improvement of professional skill of the faculty and employees;
 - Creation of innovative-educational (scientific) consortia;
 - Publication and exchange of materials, on researches spent in high schools;
 - Organizing and carrying out of symposiums, seminars, scientifically-practical conferences, round tables, space bridges, etc.;
 - Informing of the public on activity of high schools, within the limits of the Contract.

4 Forms of co-operation

- 4.1 Parties agree that the optimal form of co-operation is the establishment of direct communications between two interested parties in the concrete areas which are based on interests of separate faculty, chair or the concrete student, employee, and in shape, the most comprehensible to both Parties.
- 4.2 Parties agree that scientific cooperation between the Parties will be carried out on the basis of working programs which will be signed by corresponding representatives, after the coordination of conditions, that and participants of scientific cooperation.

5. Financing

5.1 Financial mutual relations of the Parties on realization of joint actions, projects (programs), and also other obligations within the limits of the Contract, will be defined by the contracts (agreements) issued in addition, being an integral part of the Contract.

6. Other conditions

- 6.1 Parties have the right to make changes and additions to the Contract by registration and signing of the additional contract.
- 6.2 The Contract doesn't impose legal obligations on any of the Parties which have signed it. The actions undertaken by the Parties in common and following from the Contract will be a subject of the separate written agreement or the contract. Legal relations between the Parties will be built during realization of the similar agreement or the contract.
- 6.3 The Contract comes into force from the date of its signing and operates 5 (five) years with the right of automatic prolongation to the following 5 years if any of the Parties hasn't expressed desire to terminate the Contract and hasn't informed other Party about it.
